New advanced metering system selected

It's no secret that technology is constantly growing and advancing at break-neck speeds. For example, let's think back all the way to 2009. What were the televisions like back then? What kind of cell phone did you have in 2009, if you had one? How far has agricultural equipment

come from that time? The energy sector is not immune to these rapid technological developments either.

Advancements in metering technology since our current system was installed 12 years ago is nothing short of amazing. New systems can now narrow down outages to a specific meter, which will help in reliability as well as restore your power more quickly. They can also give us loads of data and information, so we know where equipment upgrades need to take place. These equipment upgrades will help with improved power quality, efficiency, and reliability.

With a new advanced system comes more information for you, the member. We are currently working with our billing software company so your individual usage will be available to you 24/7/365. This usage will be reported on every hour of every day so it's easier to pinpoint when a spike or dip may have occurred.

Because of the reasons mentioned above, along with the obsolescence and lack of support for our current metering system, your board of directors recently selected a new advanced metering system. This system will be supplied by Tantalus with a deployment date scheduled for July 2022.

Cold? Use your space heater safely

Electric space heaters can help quickly take the chill off, but they can be dangerous if used incorrectly. Your Touchstone Energy cooperative urges everyone in your home to understand the importance of using space heaters safely:

- Purchase only space heaters that have been safety tested and UL approved with an emergency tip-over shut-off feature and heating element guards.
- Before using a space heater, make sure your smoke and carbon monoxide detectors are in good working condition.
- Make sure the heater is clean and in good condition, and have all problems professionally repaired.
- Place the heater out of high-traffic areas and on a level, hard, non-flammable floor surface—NOT on carpets, furniture, or countertops.
- Space heaters have one purpose—to provide supplemental heating. Never use them to thaw pipes, cook food, or dry clothing or towels.
- Remember to keep space heaters at least three feet from combustible liquids and flammable items.
- Never allow pets or children near an electric heater.
- Do not overload circuits. Never use extension cords or multiple plugs with a space heater.
- If your space heater is plugged into a ground fault circuit interrupter (GFCI) and the GFCI trips, immediately stop using the heater until a professional can check it.
- Turn off your space heater and unplug it before leaving the room or going to bed.
- Replace older space heaters with newer, safer models.

In addition, space heaters are not inexpensive to run. Be sure to contact us to find out how much using your space heater might add to your electric bill.

BE SAFE DURING THE **HO-HO-HOLIDAYS** 10 TIPS TO HELP YOU STAY JOLLY



Before you plan out your new holiday lighting scheme or repeat last year's festive design, keep these 10 safety tips in mind when decorating outdoors:

- 1 Do not toss light strands up into the air. They could get too close to or come into contact with a power line.
- 2 Before using a ladder, always look up and assess all power line locations.
- 3 Carry a ladder horizontally when transporting it.
- 4 Keep at least 10 feet between yourself (and any item you are holding) and a power line.
- 5 Do not use staples or nails or tacks to secure light strands, cords, wires or extension cords.
- 6 String together no more than the number of strands recommended by the manufacturer.
- 7 Plug all lights and extension cords into GFCI-protected outlets.
- 8 Use lights and extension cords rated for outdoor use.
- 9 Do not use frayed, cracked or otherwise damaged cords, plugs or lights.
- 10 Use only lights and products certified by a reputable testing lab.
